General Information

Thank you for your interest in working at Veterans Memorial Aquatic Center & Park Store. Veterans Memorial Aquatic Center offers students a fun and rewarding outdoor working environment. We have flexible hours to fit your summer vacation and sporting activity schedules. **We are only interested in those students that will be available for the entire summer season, which begins May 20th to August 25th.**

Reserve\ Part Time\ Full Time Positions

Part Time

Those with summer activities and more than (1) planned vacation, part time might fit their schedule better. Staff is scheduled approximately 15 to 20 hour per week.

Full Time

Full time positions are for those with no summer activities and (1) planned vacation. Staff is scheduled approximately 30 to 40 hours per week.

Reserve

Those applicants with numerous summer activities & more than (1) vacation planned during the summer. Staff is available on an "On Call Basis". No scheduled hours. Regardless of whether or not you are applying for a full, part time, or reserve position, **applicants must be available for the entire summer season. (May 25th to August 25th)**

Applicant Swimming Test

For applicants that we have no knowledge or record of their swimming skills, **the American Red Cross Lifeguard Training Swimming Skills Test** will be required as part of the application process & requirement. Applicants needing a swimming test will be informed of the test at the time of their interview.

American Red Cross Lifeguard Training Course Required Swimming Skills Test Swimming Event

Swim 200 yards continuously demonstrating breath control and rhythmic breathing using the crawl stroke.

Swim 100 yards demonstrating the skill of doing the Breaststroke using a pull, breath, kick, and glide sequence

Timed Event

Starting in the water, swim 20 yards using the front crawl or breaststroke, surface dive 7-10 feet, retrieve a 10 pound object, return to the surface, swimming 20 yards back to the starting point with both hands holding the object and exit the water without using a ladder or steps within 1 minute, 40 seconds.

Tread water for 2 Minutes using only the legs\hands under the armpits

Aquatic Center\Park Store Job Descriptions

Life Guards

The required age for lifeguards is 16 years of age required by the State of Wisconsin. A lifeguard must hold current certifications in lifeguard training, first aid, CPR, and AED. Responsibilities include but not limited to the supervision of swimmers and the enforcement of the rules and regulations developed and established by the Wisconsin Administrative Code for the Operation of Public Swimming Pools and the City of Evansville.

Water Safety Instructors

The required age for Water Safety Instructors is (16) years of age. A water safety instructor must hold a current certification in the American Red Cross Water Safety Course or complete in-house training\instruction for teaching swimming lessons according to Red Cross Standards. Current certifications in first aid, CPR, AED and lifeguard training are required. Responsibilities include but not limited to teaching all age level swimming courses according the standards set forth by the National American Red Cross Swimming Lesson Program and the standards established by the City of Evansville.

Basket Room Clerk\Admissions

The minimum required age for a basket room clerk is (15) years of age. The basket room clerk must be able to perform the basic swimming skills required to become a life guard. Responsibilities include but not limited to checking in and out the patrons

using the facility, enforcement of the established supervision and age requirements to use the facility, daily admission sales, seasonal pass sales, and swimming lesson registrations. The clerk updates and maintains the seasonal registrations and swimming lesson records in the aquatic center computer. Answering the aquatic center phone and providing the public with accurate information about the aquatic center activities are also part of the clerk's duties. Applicant must have the required swimming skills to take the Red Cross Lifeguard Training Class.

Park Store Clerk\Concessions

The minimum age for a park store clerk is (15) years of age. The park store clerk must be able to perform the basic swimming skills required to become a life guard. Responsibilities include but not limited to serving concessions, keeping the park store clean and orderly, and carrying out all of the rules and regulations established by the Rock County Department of Health and the City of Evansville. Applicant must have the required swimming skills to take the Red Cross Lifeguard Training Class.
