Neeley read the following email that was received from swim teacher Mary Beth Anderson:

My name is Mary Beth Anderson and I coach the High School Girls and Boys swim teams. I also coach the Evansville Blue Sharks during the summer. With our new pool opening this spring, I have a few questions I would like to get answered before then. I would like to amp up things for our swim team. I think that we will be seeing an increase in interest in the Blue Sharks.

I would like to be able to have a total of 3 hours for practice for the ages 6-18. I would also like to add another program for the kids that can't quite make it across the pool and just need a little extra boost. Last summer I had 76 kids on the swim team and that was a low year for me. I see the team being well over 100 swimmers this summer.

I would like to hire 2 assistant coaches. I believe that would help us become a better team and more competitive and also have a lifeguard on deck during practices. I would like to ask to also purchase a few things for the running of this program. I would like to purchase 2 Deck Standing Pace clocks (Competitor 37in. Battery Powered Pace Clock \$735-Swim Outlet), Colorado Infinity Starting system (Kiefer Aquatics \$1,159.60), Active HyTek Meet Manager and Team Manager (Meet Manager \$499, Team Manager \$395). This software helps organize and run meets efficiently. I am hoping to host more meets at our pool which means that we will need to order ribbons (est. 300 ribbons/\$100) and maybe medals if we hold a larger meet with multiple teams. We are in need of at least 8 stopwatches to run the meets, 8 clipboards, a bullhorn, 2 sets of backstroke flags. Of course I would also like to have a laptop assigned just for the swim team. There is a lot of work that needs to be done off deck with running the team and the amount of meets that I would like to have the kids doing.


Tess Romanski from CSA Coalition spoke to the committee about the bike ride starting and ending at Lake Leota Park on September 15, 2024. This is the 16th ride the CSA Coalition has done and they are expected to have 800 riders participating in this ride. There are two different routes riders can take 35 miles or 60 miles. The riders will be visiting four farms on the route Winter Fell Acers, TP Produce Farm, Still Point Flower Farm, and Uwalay Farms. Goes from 8 a.m. to 6 p.m. with staggered starts at 9 a.m. & 10 a.m. Tess Romanski says they cap the riders at 800. Chief Reese and Chief Kleisch will meet the CSA Coalition later to go over the routes and safety issues.

Amending the City of Evansville's Fee Schedule – Swimming Pool Rates

WHEREAS, Wisconsin Statutes section 66.0628(2) holds, "Any fee that is imposed by a political subdivision shall bear a reasonable relationship to the service for which the fee is imposed;"

WHEREAS, the costs to maintain pool operations has increased.

WHEREAS, the City has a priority on providing top notch services and amenities to residents and users.

WHEREAS, the City is excited to welcome the opening of a new and expanded aquatic center and splash pad, creating the widest variety of recreation amenities to date for citizens.

WHEREAS, Staff recommends increasing and imposing fees to reflect continued increased maintenance and staffing costs of facilities;

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Common Council of the City of Evansville that the City of Evansville's Fee Schedule is amended, effective upon adoption, as follows:
