 - Our application to the East Asia in Wisconsin Library Program will be fully funded in the amount of \$740.
 - The intent of the program is to give public libraries in Wisconsin the opportunity to enrich their collections with new materials and to support programming that will enable residents to deepen their understanding of East Asia (China, Japan, the Koreas, Mongolia, Tibet, Hong Kong, and Taiwan).

 - Rock County applied for a grant through the American Rescue Plan Act to fund a business development initiative. This revolves around the county purchasing a subscription to an online business plan development tool as well as partnering with Rock County libraries to get the public connected to the service.

- C. **Plan Commission Report** Sergeant reported that there were 3 properties that had zoning approvals in the last couple of years that are current not compliant. The engineers are going to go check on the properties and there will be formal letters sent to the property owners to get them in compliance.

Purchase of Services Agreement -EXTENSION-

By and Between The City of Evansville and Humane Society of Southern Wisconsin

THIS CONTRACT EXTENSION AGREEMENT (the "Extension"), is dated as of January 1, 2022 (the "Effective Date"), by and between the Humane Society of Southern Wisconsin ("HSSW"), a not-for-profit corporation located and conducting its principal business at 222 S. Arch Street in the City of Janesville, Rock County, WI 53548, and the City of Evansville (the "CITY") (collectively, the "Parties").

RECITALS

WHEREAS, the Parties entered into a certain *Purchase of Services Agreement* on January 1, 2018, with an original expiration date of December 31, 2021 (the "Original Contract"). A copy of the Original Contract is attached hereto as Exhibit A and is incorporated into this Extension: and

WHEREAS, the Parties agree to extend the Original Contract for the extended term period covering January 1, 2022 through and including December 31, 2025; and

WHEREAS, the ORIGINAL CONTRACT shall expire on December 31, 2021: and

WHEREAS, both Parties desire and hereby agree to renew and extend the terms of the Original Contract for four (4) years in accordance with the provisions set forth in the Original Contract; and

WHEREAS, this Extension binds and inures to the benefit of both Parties.

Now, in consideration of the good and valuable covenants and consideration contained in the Original Contract, the HSSW and the CITY mutually covenant and agree as follows:

- 1. Each of the above recitals, and the Original Contract, are reiterated and incorporated herein by reference as if fully set forth verbatim:
- 2. THIS SERVICES AGREEMENT (the "Agreement"), made and entered into on the first day of January, 2018, by and between the Municipality ("City Of Evansville") and Humane Society of Southern Wisconsin ("HSSW"), a not-for-profit corporation located at 222 S. Arch Street in Janesville, WI.

RECITALS

- 0.1 WHEREAS, the Municipality desires to purchase services from HSSW for the care, treatment, and humane disposition of stray animals located within the geographic limits of the Municipality; and
- 0.2 WHEREAS, HSSW, a Wisconsin not-for-profit corporation that is independent of the Municipality, is presently situated to provide animal shelter and care services; and
- 0.3 WHEREAS, at all times this Agreement shall be construed in a manner so as to maximize the welfare of the animals who are the subject hereof and who are cared for by HSSW pursuant to the terms of this Agreement; and
- 0.4 WHEREAS, the Municipality and HSSW's fiscal year runs from January 1 through December 31 of each calendar year; and
- 0.5 WHEREAS, HSSW maintains a principal place of business located at 222 S. Arch St., Janesville, Wisconsin 53548; and
- 0.6 WHEREAS, HSSW is a non-profit corporation entering into a contract with a political subdivision as defined in Wis. Stat § 173.15(1) and acknowledges its obligations under Wis. Stat, § 173.15(2) in relation to said contract; and
- 0.7 WHEREAS, the municipalities vested with jurisdiction have the authority and/or obligation to enforce:
 - (i) Chapter 173 of the Wisconsin Statutes ("Animals; Humane Officers")
 - (ii) Chapter 174 of the Wisconsin Statutes ("Dogs")
 - (iii) Chapter 951 of the Wisconsin Statutes ("Crimes against Animals")

AGREEMENT

Now, therefore, in consideration of the above Recitals (which are acknowledged to be true and correct and are incorporated into this Agreement) and the promises and agreements hereinafter contained and for other good and valuable consideration (the receipt and sufficiency of which is hereby acknowledged by each party to this Agreement), it is agreed by the Municipality and HSSW as follows:

1.0 SERVICES

HSSW agrees to provide the services fully incorporated herein by reference. In the event of a conflict between the Municipality and HSSW, or the terms of this agreement, the terms of this agreement are controlling.

2.0 COST

Municipality shall pay for services detailed in this agreement a flat fee of \$3,500 yearly for services, invoiced monthly in 12 equal payments.

3.0 TERM OF AGREEMENT & Obligations

The term of this Agreement shall commence on the first day of January 2018 or as of the date by which all parties have executed this Agreement, whichever is later, and this Agreement shall terminate on December 31, 2021, unless sooner agreed to in writing by the parties or renewed by mutual agreement. The Agreement may also be terminated before December 31, 2021 if subject to termination under Section 6.0. HSSW shall complete its service obligations under this Agreement no later than the Expiration Date, and Municipality shall not be liable for any services performed by HSSW other than during the term of this Agreement. HSSW shall not be obligated to complete any services other than during the term of this Agreement.

4.0 DEFINITIONS

As used in this Agreement, the following words shall have the meanings provided below:

- **4.1 Companion Animals:** Dogs, cats, rabbits, guinea pigs, hamsters, mice, ferrets, birds, fish, reptiles, amphibians, invertebrates, or any other species of domestic animal sold, transferred, or retained for the purpose of being kept as a household pet.
- **4.2 Redemption:** The identification and verification of ownership of a stray or abandoned animal and the return of the animal to its owner.
- **4.3 Stray:** A companion animal found wandering at large whose owner or custodian is unknown or cannot be ascertained immediately with reasonable effort.
- 4.4 Unclaimed: A companion animal that is found abandoned or stray whose owner has failed to redeem the animal.
- 4.5 Feral Cat: A feral cat is a domesticated cat that has returned to the wild, or the offspring of such a cat. It is distinguished from a stray cat, which is a pet cat that has been lost or abandoned.

5.0 DESCRIPTION OF SERVICES

- **5.1** <u>Cooperation.</u> HSSW agrees to use commercially reasonable methods in working with all Municipality departments, agencies, employees, and officers and the employees and officers of the Department of Public Health Rock County in providing the services described herein. The Municipality agrees to use commercially reasonable methods in working with HSSW in order to enable HSSW to provide the services described herein and in paying for such services.
- 5.2 <u>HSSW Personnel.</u> HSSW agrees to secure, at its own expense, all personnel necessary to carry out its obligations under this Agreement. Such personnel shall not be deemed to be employees of the Municipality. HSSW shall ensure that its personnel are instructed that they do not have any direct contractual relationship with the Municipality. Except as otherwise provided in this Agreement, Municipality shall have no authority over any aspect of HSSW' personnel practices and policies and shall not be liable for actions arising from such policies and practices.
- 5.3 <u>Services for Intaking Stray Animals.</u> WHEREAS, the Municipality acquires stray animals and is desirous of a proper place to keep such animals where they will receive humane care; and WHEREAS, HSSW is an organization devoted, among other things, to the care of animals and has facilities to provide for proper care in a humane way for stray animals. NOW, THEREFORE, in consideration of the covenants herein contained, the parties agree as follows:
- 1. HSSW agrees to accept for shelter, stray companion animals from the Municipality and citizens who find stray animals within the Municipality and provide the animals with food, shelter, water, and humane care.
- 2. This agreement shall include companion animals only as defined in section 4.1.
- 3. The Municipality shall pay HSSW a flat fee per year and shall be paid in 12 equal amounts monthly or as one lump sum in January each year.
- 4. HSSW will accept stray animals during normal business hours. (Excluding major holidays when the shelter is closed).
- HSSW staff will assist in the pickup of stray animals between 8am 5pm only for an additional \$100 service fee, if requested by municipalities' officials. Must contact Brett Frazier (608) 359-5739 or James Hurley (608) 728-2290.
- 6. In the event that the Municipality should request HSSW to hold an animal for longer than the stray or quarantine hold period (i.e. police evidence holds, seized animals, etc.), the Municipality shall notify HSSW in writing and the Municipality agrees to pay HSSW at the extended rate of \$35.00 per day beyond the normal stray hold period. Notwithstanding the foregoing, in the event an owner of an abandoned animal seeks to continue to enforce their ownership rights over the animal such that HSSW is obligated to continue to provide custodial care to the animal beyond the period identified above by court order the Municipality shall continue to reimburse HSSW at the rate of \$35.00 per day. HSSW will notify the Municipality if an owner enforces his/her ownership rights by court order.
- 7. HSSW shall require proof that the animal is currently immunized against rables or require payment of a rables voucher before releasing a stray animal being claimed by its legal owner as required by law.
- 8. Injured and ill animals who in the judgement of HSSW staff are in need of immediate veterinary attention shall be transported, if condition requires, to the Municipality's designated veterinary facility for assessment and/or treatment as such facility shall recommend. HSSW shall not authorize nor incur veterinary service expenses for stray animals without prior written approval and agreement for reimbursement by the Municipality. HSSW has a shelter veterinarian and will make every reasonable effort to treat non-emergency medical conditions at the shelter at the expense of HSSW. HSSW

Am

will make the determination as to which animals need emergency veterinary medical care. Note: HSSW Veterinarian is not on site at all times.

- 9. HSSW will encourage and direct feral cats to alternate resources, however it is to be understood at sometimes it is reasonable and prudent for the HSSW to intake Feral Cats. Feral Cats will not be held, as HSSW nor do the municipalities have the resources or ability to Care, Keep, or Trap, Neuter and Release at this time.
- 10. HSSW shall keep current and accurate records in compliance with state statute 173.17, and they shall be open and available for inspection by the Municipality at all reasonable times.
- 11. HSSW shall continue to submit an itemized statement to the Municipality no later than 30 days following the last day of the billable month, and the Municipality agrees to remit payment within 30 days of receipt of the invoice. In the event that a fee is disputed, the Municipality is responsible for payment in full while the accuracy of the billing is verified. Any disputes upheld will be credited on the next month's statement. The parties agree to, as expeditiously as possible, resolve the dispute as promptly as possible and without undue delay.
- HSSW will notify the Municipality where stray animals originate and when a stray animal is reclaimed by its owner.
 Notification will accompany the monthly billing statement.
- 13. This agreement is intended by the parties hereto as the final and exclusive expression of the provisions contained in this agreement, and it supersedes and replaces any and all prior contemporaneous agreements and understandings, oral or written, in connection therewith, between the parties hereto. This agreement may be modified only upon written consent of the parties hereto.
- 5.4 <u>Services for caring and Dispositioning Stray Animals.</u> HSSW shall have the sole and exclusive right under this Agreement to provide those admitting services that it deems in its professional judgment are in the best interest of the animal and the shelter environment in which the animal is maintained.
- 1. Custodial care shall include for each animal cared for under the terms of this Agreement, the provision of:
 - (i) As required by Wis. Stat, §173.41.
 - (ii) Provide sufficient food to maintain the animal in good health.
 - (iii) Provide sufficient water to maintain the animal in good health. If fresh water is not available to the animal at all times, the person shall provide fresh water daily and in sufficient quantity for the health of the animal.
 - (lv) Ensure that necessary and standard veterinary care is provided in a timely manner.
 - (v) Ensure that the animal is not kept in an enclosure unless all of the following apply:
 - a. The enclosure is of an appropriate size, as determined by the DATCP, based on the size, age, and number of animals kept in the enclosure and the length of time the animal is kept in the enclosure.
 - b. The enclosure is structurally sound and maintained in good repair to protect the animal from injury.
 - c. The enclosure is maintained in a clean and sanitary condition.
- 2. Redemption services shall include all reasonable attempts to identify, locate, make contact with, and provide written notice to an animal's owner in order to arrange for either the surrender of the animal or the return of the animal to its owner. Said efforts will be made within the statutory holding period. Notwithstanding the foregoing, the parties acknowledge that the owners of some stray and/or abandoned animals are never known or even identified such that HSSW' ability to find the owner is a legal impossibility.
- The disposition of an animal shall be within the sole and absolute discretion of HSSW. HSSW agrees to abide by the
 applicable statutory holding periods for any animal governed thereby, as required by Wis. Stat, § 173.23 Disposition of
 animals.

6.0 TERMINATION OF AGREEMENT

- 6.1 Termination; No Cause. Either party may terminate the Agreement, for any reason, at any time upon 90 days' written notice.
- **6.2** <u>Immediate Termination for Cause.</u> The following shall constitute grounds for immediate termination by the non-breaching party:

Shu

- 1. HSSW' violation of any State, Federal or local law, or failure by HSSW to comply with any applicable States and Federal service standards, as expressed by applicable statutes, rules and regulations.
- 2. HSSW' failure to carry applicable licenses or certifications as required by law.
- 3. HSSW' failure to comply with its reporting requirements contained in section 5.4, paragraph 11 of this Agreement.
- 4. The Municipality's failure to pay HSSW the monthly payment as invoiced within 30 days of receipt of said invoice.
- **6.3** <u>30-Day Termination for Cause.</u> In the event either party engages in a material breach of this Agreement other than as described in section 6.2, above, the non-breaching party shall thereupon have the right to terminate this Agreement by giving the breaching party thirty (30) days written notice of the termination.

7.0 INSURANCE and INDEMNIFICATION.

- 7.1 Indemnification of Municipality. HSSW shall indemnify, hold harmless and defend MUNICIPALITY, its boards, commissions, agencies, officers, employees and representatives against any and all liability, loss (including, but not limited to, property damage, bodily injury and loss of life), damages, costs or expenses which MUNICIPALITY, its officers, employees, agencies, boards, commissions and representatives may sustain, incur or be required to pay by reason of HSSW furnishing the services or goods required to be provided under this Agreement, provided, however, that the provisions of this paragraph shall not apply to liabilities, losses, charges, costs, or expenses caused by or resulting from the acts or omissions of Municipality, its agencies, boards, commissions, officers, employees or representatives. The obligations of HSSW under this paragraph shall survive the expiration or termination of this Agreement.
- 7.2 Insurance. In order to protect itself and Municipality, its officers, boards, commissions, agencies, employees and representatives under the indemnity provisions of this Agreement, HSSW shall obtain and at all times during the term of this Agreement keep in full force and effect comprehensive general liability and auto liability insurance policies issued by a company or companies authorized to do business in the State of Wisconsin and licensed by the Wisconsin Insurance Department. HSSW shall maintain coverage for the duration of this Agreement and for two years following the completion of this Agreement. In the event any action, suit or other proceeding is brought against Municipality upon any matter herein indemnified against, Municipality shall give reasonable notice thereof to HSSW and shall cooperate with HSSW' attorneys in the defense of the action, suit or other proceeding.

8.0 ASSIGNMENT/TRANSFER.

HSSW shall neither assign nor transfer any interest or obligation in this Agreement, without the prior written consent of Municipality unless otherwise provided herein, provided that claims for money due or to become due HSSW from Municipality under this Agreement may be assigned to a bank, trust company or other financial institution without such approval if and only if the instrument of assignment contains a provision substantially to the effect that it is agreed that the right of the assignee in and to any moneys due or to become due to HSSW shall be subject to prior claims of all persons, firms and corporations for services rendered or materials supplied for the performance of the work called for in this Agreement. HSSW shall promptly provide notice of any such assignment or transfer to Municipality.

- 9.0 NO WAIVER BY PAYMENT OR ACCEPTANCE. In no event shall the making of any payment or acceptance of any service or product required by this Agreement constitute or be construed as a waiver by Municipality of any breach of the covenants of this Agreement or a waiver of any default of HSSW and the making of any such payment or acceptance of any such service or product by Municipality while any such default or breach shall exist shall in no way impair or prejudice the right of Municipality with respect to recovery of damages or other remedy as a result of such breach or default.
- **10.0 INVOICING.** HSSW agrees to create such invoices as are required for proper billing detail. With respect to such invoices, it is understood that time is of the essence and that the failure of HSSW to comply with the time limits set forth may result in the withholding of payments by Municipality otherwise due HSSW under the terms of this Agreement.

The witness signed below, warrants that s/he has the legal authority to execute this Agreement on behalf of the Municipality and/or HSSW and to receive the consideration specified in it, and that neither s/he nor HSSW have sold, assigned, transferred, conveyed or otherwise disposed of any rights subject to this Agreement.

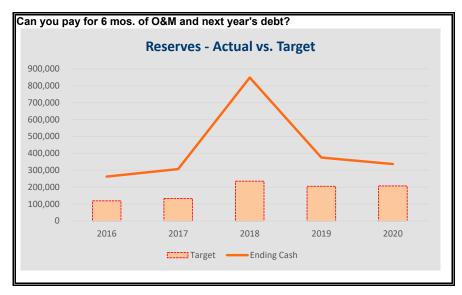

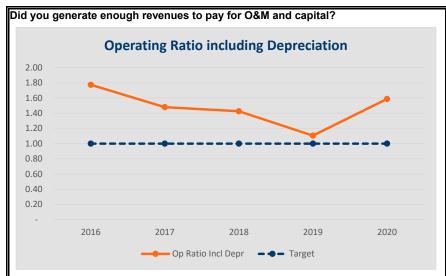

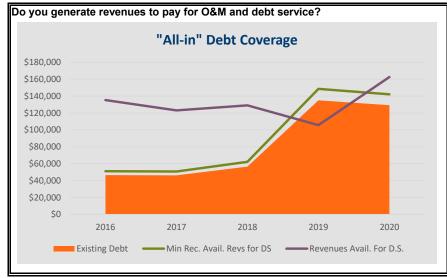

Table 3 Stormwater Utility Financial Health Charts







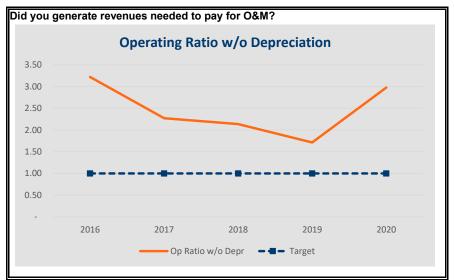

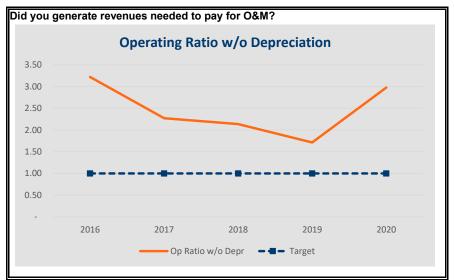

Economic Development Services

Scope:

The City of Evansville is seeking Economic Development assistance. This assistance could come in the form of, but not limited to, economic development expertise/advice, marketing and developing the City and City owned sites, and communicating with interested businesses and/or site selectors about relocating to Evansville.

Overview of Services:

Brandon Rutz will provide Economic Development expertise and services as determined by the City Administrator up to a maximum of 100 hours.

Brandon Rutz will provide the following:

- Up to 100 hours of service with direction from the City Administrator. These hours are not to exceed 20 hours in any given week unless pre-approved by Brandon Rutz.
- Be available most Monday, Tuesday, and Thursday mornings (8am-12pm) for meetings and/or work on site at City Hall if desired. See below for days Brandon Rutz will be out of office. These days and times may change depending on Brandon Rutz's other commitments. If they need to change, new days and times will be communicated and agreed upon with the City Administrator as soon as they are known.

The City of Evansville will provide:

- A place to work at City Hall if desired to do so.
- Direction and information on the duties expected in sufficient detail to permit Brandon Rutz to perform such duties.

Weekly times and days that Brandon Rutz will not be available:

- Sunday through Thursday 1pm 11pm
- Fridays through Sundays, unless pre-approved ahead of time or an emergency.
- Note: these times/days may change. If they do, Brandon Rutz will provide at least 2 weeks notice of the change.

Out of office dates:

- No known outages at this time. If outages arise Brandon Rutz will provide at least 2 weeks notice of the outage.
- For sick or unexpected outages, Brandon Rutz will call and email the City Administrator as soon as possible.

Fee Schedule:

- \$10,000 to be paid on or prior to December 31st, 2021
- If services are required above and beyond the total 100 hours they will be pre-approved by the City Administrator and charged at \$125/hr.
- Upon reaching 20 hours remaining, the expectation is to assess the amount of hours remaining and determine if an additional retainer contract is desired. If an additional contract is desired, an agreeable amount of hours will be guaranteed at \$100/hr.

POLE ATTACHMENT AGREEMENT

This POLE ATTACHMENT AGREEMENT dated as of _______, 2021, for the use of facilities is between the City of Evansville (hereinafter called "City"), and Spectrum Mid-America, LLC (hereinafter called "Licensee").

WITNESSETH

WHEREAS, City owns, operates, maintains, and controls certain electric power distribution poles (hereinafter "poles") within the City of Evansville, Wisconsin; and

WHEREAS, Licensee proposed to place and maintain aerial cables, wires, related equipment reasonably necessary for the use of wire or aerial cables and related equipment reasonably necessary to attach wire or aerial cables to City poles at specific locations in City's service area and desired to attach such facilities to poles or structures owned and maintained by the City; and

WHEREAS, City is willing to permit, to the extent it may lawfully do so, the attachment of Licensee's facilities to its poles on a non-exclusive, but non-discriminatory basis, where safety will not be adversely affected and such use will not interfere with City's own service requirements and with the rights and privileges of other parties currently using City's poles.

NOW, THEREFORE, in consideration of the foregoing recitals and the covenants, terms and conditions hereinafter contained, the parties hereto do hereby mutually covenant and agree as follows:

ARTICLE I

Scope of Agreement

1.1 General Scope.

This Agreement shall be in effect and shall apply to all Attachments made by Licensee to poles owned by City now existing or hereinafter erected and such poles are included within the scope of this Agreement in accordance with the procedures set forth below. City reserves the right to exclude use of its poles from joint use, on a nondiscriminatory basis, where, in the judgment of the City joint use would be unsafe or violate a rule or, regulation, or generally applicable engineering practices.

1.2 Rights of Parties.

The rights and privileges of Licensee shall be subject to the rights and privileges of others upon whom City has conferred contractual rights or privileges to use its poles prior to the execution of this Agreement, or predecessors to this Agreement. Notwithstanding the foregoing, to the extent Licensee has existing Attachments, those attachments and rights of other parties shall be subject to Licensee's preexisting Attachments and rights thereto.

1.3 Authorization.

Subject to the provisions of this Agreement, City agrees to grant to Licensee a license for the nonexclusive right to attach its facilities to certain designated City poles. No use of City poles, however extended, or payment of fees or charges required under this Agreement, shall create or vest in Licensee any ownership of property rights in such poles. Licensee's rights herein shall be and remain a mere license for the duration of this Agreement.

1.4 Assignment.

Licensee may not assign its rights under this Agreement to any other person or entity without City's prior written consent, which consent shall not be unreasonably withheld. Notwithstanding the foregoing, Licensee may, without pole owner consent, assign its rights under this Agreement to any entity it controls, or is controlled by. The licensee shall provide notice to the City of any such assignment.

1.5 Authorizations Required.

Licensee shall secure all legally required authorizations permits and any other approvals required by any governmental authority or private entity for the construction, operation, and maintenance of its facilities.

ARTICLE II

Definitions

- 2.1 For purposes of this Agreement, the following terms shall have the following meanings:
 - 2.1.1 Pole means an electrical power distribution pole owned and maintained by City.
- 2.1.2 Attachment means any and each wire, cable or other equipment or apparatus, including a service drop contact, attached directly to a City pole.

ARTICLE III

Reservation of Primary Use

3.1 Primary City Use.

City specifically reserves its right to maintain its own facilities and to operate its own equipment thereon in such a manner as will best enable it to fulfill its own service requirements. City shall not be liable to Licensee for any interruption of Licensee's service or for any interference with the operation of Licensee's facilities in any manner except by negligence or intentional misconduct of City. Notwithstanding the foregoing, City shall correct and remedy actions it takes that creates an interruption or interference with the operation of Licensee's services.

ARTICLE IV

Application for Attachment

4.1 Permit Application.

Except as set forth herein, Licensee shall not attach any of its Attachments to City's poles without first making written or electronic application to City for a permit and receiving written or electronic permission from City in the form of a permit. For the purposes of this Agreement, Licensee's facilities shall include wire or fiber cables to operate its lawful communications system, any related equipment reasonably necessary for the operation of that system, including equipment reasonably necessary to attach wire or fiber cables on City poles. Under this agreement, Licensee's Attachments shall not include Wi-Fi equipment or any other device used for the provision of wireless internet, wireless phone service, or an antenna of any kind.

4.2 Application Procedure.

Whenever Licensee desires to attach its Attachments to any City pole, Licensee shall make application for a permit using a Permit Application Form specified by City. The fee for the application is _____ per pole. City shall have the right to deny or request modification of the application if there is insufficient capacity, or for reasons of safety, reliability or generally applicable engineering reasons that cannot be remedied through make-ready work under this Agreement. City will approve or deny an application within forty-five (45) days of Licensee's submission of a complete Permit Application Form.

- 4.2.1 The application shall include sufficient drawings, specifications and information necessary so that the City, or its designee, can designate necessary makeready, in conformity with code, regulation and generally applicable engineering practices.
- 4.2.2 If the application is approved, Licensee shall have the right to affix such Attachments in accordance with the application, as approved, in compliance with the specifications, terms, and conditions of this Agreement, in compliance with all applicable ordinances, statutes, codes, rules, regulations, and in conformity with generally applicable engineering practices.
- 4.2.3 City, upon receipt of an application, may contact the applicant to schedule an evaluation "ride out" with personnel from Licensee and City. For all ride outs, appropriately qualified personnel representing Licensee and City representative shall meet at the location of the proposed Attachment to determine if the Attachment or modification can be made, and to review technical requirements.

4.3 Installation; Certification.

Each application shall involve sufficient information so that City can ensure compliance with ordinances, statues, codes, rules, regulations and good practice during construction and upon completion.

- 4.3.1 Licensee shall only use trained, qualified persons to work on all pole installations. Qualified persons shall be knowledgeable in applicable ordinance, statute, code, rules, regulations and standard industry practices and must be able to demonstrate competence in recognizing and preventing any ordinance, statute, code, rules, regulation and standard industry practice violations and to keep working clearances from energized lines and equipment.
- 4.3.2 Upon completion of the installation, Licensee shall give written confirmation to City that the installation is complete and complies with ordinance, codes, rules, regulations and good practices so that City may post-inspect. If the installation is found to be in violation of any applicable standards noted above, or if there are deviations from the original design specifications, City will make Licensee aware that corrections must be made within thirty (30) days of receipt of notification, or such other time mutually agreed to by the parties. If Licensee does not make corrections in thirty (30) days, City will make the corrections at Licensee's expense. If corrections are unable to be made, the Attachment shall be removed.

4.4 Make Ready Work; Charges.

Whenever any City facility must be modified to accommodate any proposed Attachment, City will provide Licensee with a detailed estimate of "make ready" work it determines is necessary to prepare the pole for Licensee's facilities. After receiving this estimate, if Licensee still desires to make such Attachments, Licensee shall notify City within fifteen (15) days of receiving such estimate of such continuing desire to attach, and shall pay to City within 30 days of invoicing (after Licensee approval) any required payment for the estimated make-ready, including engineering, materials (including poles and associated hardware solely attributable to Licensee's Attachment), cost of removal (less any salvage value), and the expense of transferring City's facilities from the old to the new poles. City shall commence all requested make ready and pole replacement work within thirty (30) days of receiving any work request confirmation.

4.5 Non-Interference with City Facilities.

Licensee shall at all times insure that its agents, servants, employees or contractors or contractor's employees do not interfere with City's wires, attachments, and other facilities attached to or supported by poles covered by this Agreement. Each party shall exercise reasonable precautions to avoid damage to the facilities of the other. Without limiting the foregoing, Licensee's Attachment design shall allow adequate climbing space for City personnel.

4.6 Changes or Modifications to Existing Attachment.

Licensee shall not make any changes or modifications to an existing Attachment that results in an increase in the height of the pole, or that increase the weight or location of Attachments on the pole without having the express written permission from City or as otherwise directed by City, e.g., to accommodate another attacher, to assist in the correction of a safety violation, to transfer to another pole, etc. Except for routine maintenance and in emergencies, Licensee shall make application to City for modifications as provided in Article IV.

ARTICLE V

Unauthorized Attachments

5.1 Unauthorized Attachments.

If Attachment is made after the effective date of this Agreement without required permission and/or without following a procedure which is substantially in accordance with this Agreement, such Attachment shall constitute an "Unauthorized Attachment".

5.2 Application for Unauthorized Attachments.

Upon City's written notice to Licensee specifically identifying the pole and location of any Attachment City claims to be unauthorized, and upon Licensee's written verification acknowledging its ownership City may, without prejudice to its other rights or remedies under this Agreement, require Licensee to submit a Permit Application within thirty (30) days after the date of Licensee's written or electronic verification acknowledging ownership. If such application is not received by City within the specified time period, Licensee shall immediately remove said Unauthorized Attachment. In the event the Unauthorized Attachment creates an emergency or safety hazard, the City may remove Unauthorized Attachments and the expense of such removal shall be borne by Licensee.

5.3 Failure to Act.

No act or failure to act by City with regard to Section 5.2 shall be deemed a ratification or grant of permission to Licensee to attach the Unauthorized Attachment. If any permission is subsequently issued, said permission shall not operate retroactively or constitute a waiver by City of any of its rights under this Agreement; provided, however, that Licensee shall be subject to all charges, liabilities, obligations and responsibilities of this Agreement in regard to any unauthorized Attachment.

ARTICLE VI

Identification of Facilities

6.1 Identification of Facilities.

Licensee shall identify, by such method as the City must approve, all of their facilities attached to City's poles. This identification shall begin with new attachments when this Agreement is signed. No tag, brand, or other device showing Licensee's name or insignia shall be placed on, or attached to, any pole of City, except such tag or insignia which shows Licensee to be a user of such pole and not the owner thereof, and then only after obtaining the written consent of City.

ARTICLE VII

Easements and Rights of Way

7.1 No Warranty.

City does not warrant or assure to Licensee any right of way privilege or easements or that City owns a property right which permits attachment, and if Licensee shall at any time be prevented from placing or maintaining its attachment on City's poles, no liability shall attach to City. Each party shall be responsible for obtaining its own easements and rights of way. The attaching Licensee shall solely be responsible to acquire any legally necessary property right to attach from any property owner.

ARTICLE VIII

Maintenance, Replacements, Relocations and Removals

8.1 Inspection of Facilities.

Licensee shall comply with all applicable ordinances, statutes, codes, rules, regulations and standard industry practices regarding inspection of their facilities. City shall have the right to inspect each installation of Licensee's Attachments and to make periodic inspections of all facilities on City poles, including Licensee's facilities, as it deems necessary. Such inspections, whether made or not, shall in no manner relieve Licensee of any responsibility, obligation, or liability assumed under this Agreement.

8.2 Pole Relocation.

Whenever right-of-way, safety public regulations, or other considerations arise other than as provided in Section IV herein, make relocation of a pole necessary or advisable, such relocation shall be made by City at its own expense, except each party shall pay the cost of transferring its own attachments.

8.3 Relocation of Facilities.

- 8.3.1 Whenever it is necessary in City's sole judgment to replace or relocate a pole, City shall, except in emergencies, before making such replacement or relocation, give Licensee at least thirty (30) days notice thereof specifying in such notice the time of such replacement or relocation. In an emergency, verbal or electronic notice will be attempted (except after hours emergencies for which no notice is required), and any emergency action taken will be subsequently confirmed in writing.
- 8.3.2 Placement of relocated poles shall be at the sole operational discretion of City, although where possible consideration shall be given to a pole placement that results in the least cost to City and Licensee. Notwithstanding this section, City shall not be liable to Licensee for the cost of relocating its facilities on a replaced or relocated pole. Each party shall bear the cost of transferring its own attachments.
- 8.3.3. City shall provide Licensee with written or electronic notification at such time as sufficient work has been completed to allow the transfer of Licensee's facilities. Licensee shall transfer its Attachments within thirty (30) days of said notification unless other circumstances arise making the thirty (30) day requirement impossible. Should Licensee fail to transfer its Attachments to the new or relocated pole in the time specified, or if the failure to transfer said attachments results in an emergency or safety hazard, City may transfer Licensee's facilities, and Licensee shall pay City the cost thereof. In the event Licensee fails to transfer its Attachments and City does such work, City shall not be liable for any loss or damage, including incidental and consequential damages or lost revenues to Licensee's facilities or business which may result, except where such damages are caused by City's or willful misconduct. City shall notify Licensee of such transfers following the work.

8.4 Condition of Attachments.

Except as otherwise provided, each party shall at all times maintain all of its property and Attachments in accordance this Agreement, and shall keep them in good repair.

8.5 Non-Conformance with Specifications.

Should the City discover, at any time, an Attachment that is permitted, but otherwise in violation of the safety requirements or the terms and conditions of this agreement, including an Attachment that may have been conforming at one time but that Licensee caused to come out of compliance, the City shall notify Licensee, and excepting emergency and/or safety situations, Licensee shall cure the non-conformity within thirty (30) days after the date of such written or electronic notification (If the Licensee believes that the nonconformity is not curable with a thirty (30) day period, upon consent of the City, said consent to not unreasonably be withheld, the period will be extended provided that if Licensee substantially commences to cure such non-conformity and proceeds diligently thereafter to effect such

cure). In those situations where Licensee's failure to conform to the terms and conditions of this agreement is deemed by the City to result in an emergency and or safety hazard, the City may immediately remove Licensee's facilities at Licensee's sole risk and expense. Nothing in this section shall require Licensee to conform existing Attachments to new or revised code specifications where the applicable code does not so require, including any new or revised specifications of the City. In all circumstances, NESC grandfathering rules shall apply to any and all safety standards and existing Attachments.

8.6 Licensee Assumption of Responsibility.

Licensee expressly assumes responsibility for determining the condition of all poles to be climbed by its employees, contractors, or employees of contractors. City disclaims any warranty or representation regarding the condition and safety of the poles of City. Licensee's employees or contractors shall take all reasonable steps to ensure that a pole is safe to be used or climbed upon and in the event of doubt, shall not proceed and shall seek reasonable assistance. Regardless of whether contact has been made by City or not, any pole that is marked with an orange "X" is deemed unsafe to climb or have any objects, such as a ladder, leaned up against it.

8.7 Replacement of Deteriorated Poles Without Attachments.

Should City replace any poles because of deterioration or the requirements of public authorities or property owners, or in City's sole judgment for the benefit of its system, and should Licensee desire to occupy the new pole, Licensee shall reimburse City for the cost of any increment of pole height or strength provided specifically for Licensee's sole requirements over and above the pole height and strength required by City.

8.8 Increased Pole Space Requirements.

Should City replace any poles because of increased requirements of more than one pole occupant, including Licensee, but not Licensor, Licensee shall be responsible for its transfer costs from the old pole to the new pole and for the costs of City on a pro rata basis with other pole licensees. In any case where facilities of City or of others are required to be rearranged on the poles of City to accommodate the Attachments of Licensee, Licensee shall pay to City the total cost incurred by City in rearranging such facilities. In any case where Licensee's facilities are required to be rearranged to accommodate the Attachments of a third-party, City shall first notify the third party of the existence of Licensee's facilities and shall require proof from the third-party attacher that satisfactory arrangements have been made with Licensee for reimbursement of any expense occasioned by the third-party's request.

8.9 Noninterference with City Circuits.

Licensee expressly agrees that City's circuits are to continue in normal operation during Licensee's performance of any construction or maintenance, and that Licensee is to provide and use all protective equipment necessary for the protection of the public, the City, and Licensee's employees, contractors, and equipment, and Licensee shall guard against interference with normal operation of City's circuits.

ARTICLE IX

Abandonment of Poles and Removal of Attachments

9.1 Notice.

Licensee may at any time remove its facilities from any of City's poles and, in such case, Licensee shall immediately give City written or electronic notice of such removal identifying from what locations and on what date equipment was removed. Removal of said facilities from any of City's poles shall constitute a termination of Licensee's permit to use such poles.

9.2 Pole Abandonment

If City desires at any time to abandon any pole(s), it shall give Licensee notice in writing or in electronic form to that effect at least thirty (30) days prior to the date on which it intends to abandon such pole(s). If Licensee desires to maintain its Attachments, then Licensee shall notify City and City shall, when feasible, negotiate in good faith mutually acceptable terms and conditions for the sale of the pole(s) to Licensee. If Licensee does not desire to maintain its Attachments, then Licensee shall remove its Attachments prior to the date on which City intends to abandon the pole(s). If, at the expiration of such notice period, Licensee has not removed all of its Attachments from such poles, City may remove Licensee's Attachments and charge Licensee a reasonable fee for such removal.

9.2.1 Should Licensee buy the pole, as specified herein, Licensee agrees and understands that it shall assume total responsibility for, and hold City harmless therefrom, maintenance, replacement and/or disposal requirements mandated by local, state and/or federal law. Licensee recognizes and acknowledges that it is taking title to the pole for all purposes. Licensee further recognizes and acknowledges that utility poles and related items may contain various hazardous chemicals or properties and that Licensee shall become familiar with the terms of the appropriate material safety data sheet and agrees to comply with such terms and all directions contained therein or otherwise required by local, state and/or federal law regarding the maintenance, replacement and/or disposal of the pole. Licensee also understands the City does not warrant, guarantee or imply that such poles possess sufficient mechanical strength as required by any use of Licensee. Additionally, Licensee agrees and understands the City makes no representations or

guarantees concerning any right to occupy the premises where the pole is currently located upon the removal of City's facilities.

ARTICLE X

Rentals, Charges and Rates

10.1 Rental Rate.

Licensee shall pay to City rental fees on an annual basis, in accordance with the fee schedule established by the Common Council from time to time pursuant to applicable law. Rental shall be calculated on a per-pole basis, for any Attachments existing as of December 31. There shall be no prorating of rentals for partial years.

10.2 Billings.

Annual invoices shall be rendered on or about October 1 of each year based on the number of City poles with Licensee Attachments existing as of December 31 of the prior year. Invoices shall be considered delinquent if undisputed amounts are not paid within thirty (30) days of the billing date. Nonpayment of any amount due under this Section shall constitute a default of this Agreement if such amount remains unpaid thirty (30) days after receipt of written notice of such nonpayment. Notwithstanding the foregoing, in the event of a bona fide dispute regarding the amount owed by Licensee, Licensee shall promptly pay any amounts undisputed from the total billing, and shall immediately set forth, with as much specificity as possible, the basis for disputing any portion of the billing.

10.3 Pole Inventory.

Licensee and City shall agree, on an annual basis, but no later than by September 1 of each year, the total number of poles which Licensee Attachments occupy.

10.4 Physical Inventory.

Licensee and City shall maintain an inventory of the total number of poles occupies by Licensee Attachments and all future rental fees shall be based on such physical inventory. City shall have the right to conduct a physical inventory of Licensee's Attachments on City poles. Licensee shall notify City if Licensee chooses to have a representative present during the inventory process. A physical inventory shall be taken no more frequently than once every five (5) years; provided, however, that City may request and require a physical inventory to be taken more frequently in the event Licensee has been found to be making unauthorized attachments.

10.5 Inventory from Plant Records.

As an alternative to performance of the physical inventory, the parties may, if mutually agreeable, determine the number of occupied poles from the number of permits approved and/or from existing maps and/or Attachment records provided that such maps or records exist and provided that each party agrees that results with reasonable accuracy can be achieved. If the parties agree to this method, any maps and/or records belonging to one of the parties and utilized to count the number of poles occupied by Licensee Attachments shall be made accessible to the other party and the number of poles occupied by Licensee Attachments shall be determined through a mutual and cooperative effort of both parties. The results of the pole counts performed in this manner shall be treated, for the purpose of determining rentals and other charges due for unauthorized Attachments, as if results were achieved by the actual physical inventory.

10.6 Payment.

Unless specifically provided for elsewhere in this Agreement, all undisputed nonrental amounts payable under this Agreement, such as for erection, rearrangement, relocation or abandonment, shall be due and payable within thirty (30) days of billing by City. Licensee shall immediately set forth, with as much specificity as possible, the basis for disputing any portion of the billing.

ARTICLE XI

Safety

11.1 Inspections.

City shall have the right to inspect each new installation of Licensee's facilities upon such poles and to make periodic inspections of all the facilities on its poles, including City's and Licensee's as it deems reasonably necessary. Such inspections, whether made or not, shall in no manner relieve Licensee of any responsibility, obligation, or liability assumed under this Agreement.

11.2 Conflicts with Electric Lines.

City shall provide Licensee notice of any ordinance, statute, code, rule or regulation violation it discovers. Ordinance, statute, code, rule or regulation violations and conflicts with electric lines shall be corrected in a prompt manner by Licensee if Licensee created the violation. In some instances, ordinances, statutes, codes, rules, or regulations may require that qualified electrical workers perform the work. In that event, Licensee shall either hire qualified contractors or pay City to perform the work. Failure by Licensee to act in a prompt and responsible manner may result in City taking appropriate measures to correct the safety violations created by Licensee and Licensee shall be responsible for the cost thereof. In such cases, the inspection, design, repair, and coordination charges shall be

borne by Licensee if it failed to perform necessary duties required by ordinance, statute, code, or administrative rules and regulations.

ARTICLE XII

12.1 Duty of Care; Reimbursement for Damages.

Each party shall exercise precautions to avoid causing damage to the other party's poles, facilities and equipment, and shall assume all responsibility for such damage to the extent said damages were caused by the party's negligence or intentional conduct. In the event damage is caused, the responsible party shall make an immediate report of the occurrence to the other party and shall reimburse the other party under this section no later than thirty (30) days from the occurrence of damages.

ARTICLE XIII

Third Party Uses

13.1 Noninterference.

Nothing contained herein shall be construed as affecting any rights or privileges conferred by City, by contract or otherwise, to others not a party to this Agreement to use any facilities or poles covered by this Agreement. City shall have the right to continue to extend such rights and privileges. The rights granted herein to the Licensee may be affected by contracts and arrangements made prior to entry into this agreement. Should any other party claim a prior right covered by this Agreement, and such claim be upheld by a court of proper jurisdiction, Licensee shall make no claim against City for damages, or otherwise, on account thereof.

ARTICLE XIV

Indemnification and Insurance

14.1 Indemnification.

Each party shall indemnify, protect, save harmless the other party from and against any and all claims and demands of any kind or nature arising out of or relating to this agreement for damages to property and for injury or death to persons, (including payments made under any Workers' Compensation Law or under any plan for employees' disability and death benefits), sustained as a consequence of that party's negligence or intentional conduct, including any claims or damages for failure to acquire a property right or have authority to attach or permit attachment to City's poles. Such obligation to indemnify, protect, save harmless and insure shall include, but not be limited to all expenses incurred in defending against any such claims or demands, including attorneys' fees, expert fees and other costs of defense.

14.2 Insurance Requirements.

While this Agreement is in effect Licensee shall carry and keep in force insurance policies with a reliable company licensed to do business in the State of Wisconsin to protect the parties from and against any and all claims, demands, actions, judgments, costs, expenses and liabilities of every kind and nature which may arise or result directly or indirectly from Licensee's activities under this Agreement which policies shall be in amounts no less than the following minimum requirements:

- 14.2.1 Commercial general liability insurance (including coverage for motor vehicle operation) and independent contractors' insurance, with minimum limits of \$2 million each occurrence and \$5 million aggregate, including coverage for contractual liability insurance. City shall be a named insured on said policy.
- 14.2.2 Workers' compensation insurance in compliance with the laws of the State of Wisconsin, and employer's liability insurance with minimum limits of \$500,000.
- 14.2.3 Licensee shall furnish City with certificates of insurance showing that such insurance is in force and will not be canceled without thirty (30) days written notice to the City Administrator or his/her designee. In the alternative, Licensee shall demonstrate to the satisfaction of City that it is self-insured and that any deductible, self-insured retention or other financial responsibility for claims shall be covered directly by Licensee in lieu of insurance.

ARTICLE XV

Term of Agreement

15.1 Five Year Term; Termination.

This Agreement shall become effective as of the year and date first written above and shall continue in effect for a term of five (5) years, subject to annual rate revisions pursuant to Section 10.1. Thereafter, this Agreement shall automatically renew from year to year unless terminated by either party by giving written notice of its intention to do so not less than 90 days prior to the end of any term. Upon termination of this Agreement, the terms of this Agreement shall continue to apply to Licensee's Pole Attachments and service drop contacts in place on City poles as of the termination date, unless and until a successor agreement has been executed.

15.2 Survival of Obligations.

Termination of this Agreement in whole or in part shall not release the parties from any liability or obligation hereunder, whether of indemnity or otherwise, which may have accrued or which may be accruing or which arises out of any claim that may have accrued or be accruing at the time of or prior to termination.

ARTICLE XVI

Default

16.1 Notice of Default; Cure

Subject to any remedies allowed for in Sections 4.4, 5.2, 8.3, 8.5, 9.2, 10.2, and 10.6 herein, if Licensee shall fail to comply with any material provision of this Agreement or should default in any of its obligations under this Agreement, and Licensee shall fail within thirty (30) days after written notice from City to correct or undertake to correct with reasonable diligence such noncompliance or default, City may at its option, and without further notice, declare this Agreement to be terminated in its entirety, or may terminate the license covering the Attachment or Attachments in respect to which such default or noncompliance shall have occurred. If the default is of such a nature that it cannot be corrected within thirty (30) days, Licensee's obligation hereunder is satisfied if Licensee within thirty (30) days and submits in writing a reasonable plan and work schedule and commitment to finish the correction promptly.

ARTICLE XVII

Ownership Rights

17.1 License Only.

No use, however extended, of any of the facilities under this Agreement shall create or vest in Licensee any ownership or property rights therein, but Licensee's rights therein shall be and remain a mere license.

ARTICLE XVIII

Notices

18.1 Delivery.

Unless otherwise provided in this Agreement, any notice, request, consent, demand or statement which is contemplated to be made upon either party by the other party under any of the provisions of this Agreement, shall be in writing and shall be treated as duly delivered when

it is either (a) personally delivered to the City Clerk in the case of notice to be given to City, or personally delivered to the office of Licensee in the case of notice to be given to Licensee; (b) received by a party after being deposited in the United States Mail, Return Receipt Requested, (c) received by a party after being sent by a reputable overnight courier, and properly addressed to the party, or (d) electronic mail, to be served as follows:

ARTICLE XIX

Supplemental Agreements

19.1 Changes.

This Agreement may be amended or supplemented only upon written agreement by the parties hereto.

ARTICLE XX

Payment of Taxes

- 20.1 Each party shall pay all taxes and assessments lawfully levied on its own property upon City's poles.
- 20.2 Licensee agrees that if any tax, fee or charge is levied against City solely due to Licensee's equipment or facilities being on City's poles, Licensee will reimburse City the full amount of said tax, fee, or charge.

ARTICLE XXI

Supplying Information

21.1 Changes.

Licensee shall promptly report to City any changes made in the number of Licensee's attachments to City's poles, as required herein.

ARTICLE XXII

Waiver of Terms or Conditions

22.1 Waiver.

The failure of either party to enforce or insist upon compliance with any of the terms or conditions of this Agreement shall not constitute a general waiver or relinquishment of any such terms or conditions, but such conditions and terms shall remain at all times in full force and effect.

ARTICLE XXIIII

Construction of Agreement

23.1 Wisconsin Law Shall Apply.

This Agreement is deemed executed in the State of Wisconsin and shall be construed under the laws of the State of Wisconsin.

23.2 Venue for Litigation.

In the event suit or action is instituted to enforce or interpret any of the terms of this Agreement, the parties agree that proper venue for said action or suit shall lie in the Circuit Court, County of Rock, State of Wisconsin.

ARTICLE XXIV

24.1 Compliance with Laws and Administrative Rules.

Planning & Feasibility Study Report Executive Summary



Evansville, Wisconsin December 10, 2021

I. Executive Summary

Background

In August of 2021, the City of Evansville, Wisconsin (the City), retained Baker Street Consulting Group (BSCG) to complete a detailed pre-campaign planning and fundraising feasibility study. The City is considering a capital campaign to raise funds for the revitalization and upgrades to West Side Park and Leonard-Leota Park (Parks Projects).

The total estimated project cost is \$10.9 million. The plan to finance this project is to acquire \$9.4 million in tax revenue (approved by referendum in November 2020) and \$1.5 million from a community-wide Capital Campaign Program.

Purposes of the Feasibility Study

The feasibility study for the City of Evansville served several ends; however, the primary goal was to assess the community's interest in supporting a Capital Campaign Program to fund the revitalization and upgrades to West Side Park and Leonard-Leota Park (Parks Projects). Also, the study sought to determine the maximum probable dollar amount that can be raised for this vision.

The central purpose of this study focused on the answers to the following salient questions:

- Is it feasible for the City of Evansville to raise \$1.5 million to achieve its vision?
- Will potential donors be supportive of the City's plans and are people willing to contribute their dollars and time to the proposed campaign?
- Is it possible for the City to assemble the necessary ingredients for launching and implementing a successful Capital Campaign Program?

In seeking answers to these questions, our objective was to determine the overall potential of the City of Evansville achieving its fundraising goals by conducting a comprehensive, well-organized community-wide campaign fundraising endeavor.

The study also helps determine how to best position the City, and/or its designee, to conduct such a campaign for achieving maximum fundraising effectiveness. This knowledge is gained by acquiring feedback on the City's plans for the Parks Projects, assessing the fundraising environment of the community, and effectively identifying potential volunteer leaders and major donors who could be rallied to support the campaign.

During the study, BSCG endeavored to identify the maximum dollar amount most feasible to raise using \$1.5 million as the proposed financial goal for the Parks Projects Capital Campaign.

A preliminary Case for Support, or Vision Statement, describing the City's aspirations, as well as an insert containing additional details and a letter inviting the recipient's participation in the study were mailed to prospective study participants. By mid-November 2021, thirty-seven (37) people participated in thirty-four (34) personal interviews regarding the proposed campaign.

Fundraising Feasibility Conclusions

Baker Street Consulting Group believes that <u>it is feasible for the City of Evansville to raise \$1.5</u> million in support of the revitalization and upgrades to West Side Park and Leonard-Leota <u>Park (Parks Projects)</u> as described in the Vision Statement.

This conclusion is due primarily to the following factors:

- Although there are still some lingering feelings of confusion, and some resentment, as to the way in which the referendum was worded, study interviewees were predominantly in favor of the improvement and revitalization plans for West Side Park and Leonard-Leota Park.
- ➤ Interviewees were overwhelmingly supportive of "their town" of Evansville and the sense of community pride is very strong.
- The two parks in question, especially Leonard-Leota Park, are highly valued for their beauty and perceived as two of the community's greatest assets.
- ➤ Overall, study respondents were very complementary about the City pursuing the Parks Projects initiative at this time. Many felt that these updates are long overdue, and they are generally supportive of the idea of a public-private approach for raising funds for the upgrades and revitalization plans.
- > Sentiments were often made by interviewees about what makes Evansville a great place to live and work, including:
 - o The small-town atmosphere.
 - Strong traditions of neighbors helping neighbors / tight-knit community.
 - o The City's high standards of maintaining a quality community.
 - Safety and quality of life resources (e.g., parks, recreation, Lake Leota, active youth sports programs, etc.).
- ➤ BSCG believes that an adequate volunteer force of local residents could be successfully assembled to help conduct a successful Capital Campaign Program for the Parks Projects.
- Most interviewees expressed that the proposed Parks Projects would result in significant, lasting improvements that would benefit Evansville now and in the future.
- ➤ Creekside Place and the Eager Free Public Library were often cited as examples of projects that were successfully supported and completed by community Capital Campaign Programs.
- > The perception that the majority of study interviewees have of the current park resources and facilities is that they are in need of being replaced, upgraded, modernized, and/or expanded upon.
- The need for the proposed components of the revitalization and upgrades plans was substantiated by most interviewees. Some indicated additional amenities (e.g., more walking/bike trails, resources / considerations for those with disabilities, etc.) should be included in these plans, even if that would require additional funds being raised in the

proposed capital campaign.

➤ BSCG believes that the community appetite for the Parks Projects additions and upgrades is not universal, but they would stimulate community pride in a positive way while producing a beneficial economic impact to the City of Evansville as well as local area businesses.

Additional Findings and Conclusions

After thoughtful consideration, Baker Street Consulting Group concludes that a successful Capital Campaign for the Parks Projects will be a viable endeavor for the City, and, with the proper motivation of volunteers and donors, result in raising substantial philanthropic revenue for this purpose.

The following additional findings and conclusions were ascertained as a result of this study:

- > Some interviewees indicated their desire to see an indoor swimming pool facility as part of the initiative rather than an outdoor aquatic center. Several sites where this could be built were referenced, including Evansville High School and Creekside Place. However, the majority of interviewees did not share this sentiment and supported the City's plans to completely replace the aging Veterans Memorial Aquatic Center with the new outdoor aquatic center and its additional planned amenities.
- > Some interviewees would like to see additional amenities or components added to this revitalization and upgrades initiative. Included among the ideas suggested to BSCG consultants were:
 - o Additional bike and walking paths.
 - Exercise routes for walking and fitness.
 - O Additional attention to the trees, flowers, gardens, and bushes in Leonard-Leota Park as well as shade/wind block trees in West Side Park.
 - Replacement of aging playground equipment and better maintenance of current facilities.
 - Restrooms and changing stations suited to children and adults with disabilities.
 - Playground and aquatic center features designed with all-ability access and use in mind.
- > The overall competition for charitable dollars, the recent completion of several other capital campaigns in the region, and uncertainties about the economy were raised as the chief concerns affecting fundraising feasibility.
- > The City will need to conduct a comprehensive Awareness Building Initiative in order to develop and strengthen its Case for Support. Select strategies will need to be designed and deliberately implemented to ensure that fundraising initiative gains a solid base of informed potential donors who are enthusiastically supportive of the campaign goals.
- > Overall, the Vision Statement used in this study detailing the Parks Projects' plans received favorable comments. However, the need to very clearly communicate the details,

- benefits, plans, and unique attributes of the Parks Projects should be heavily emphasized during the Awareness Building Initiative.
- > Study participants were largely in favor of the City's plans, but some interviewees pointed out that there needs to be more transparency and regular updates regarding the Parks Projects plans. The City will need to implement a consistent, vigorous effort to communicate the comprehensive value, benefits, and specific details associated with this ambitious community project as it progresses.
- While interviewees are generally supportive of the Parks Projects, some pointed out that there are other important projects in the community requiring near-term attention. These consist largely of ongoing maintenance and upkeep of existing facilities and completing other projects that have already been underway. (e.g., retaining wall, street repairs, etc.).

Campaign and Project Recommendations

- ➤ Baker Street recommends conducting a three-phased campaign designed to raise \$1.5 million that can be completed over a fourteen (14) month period (*Exhibit A*). Additional details are included in a Preliminary Campaign Overview, which is provided as *Exhibit D* in the Recommendations section of this report.
- During the three phases of the campaign, 20% of the dollar goal should be raised via gifts and pledges during Phase I, then the 70% raised milestone should be reached by the end of Phase II, and the remaining 10% should be secured during Phase III.
- ➤ Baker Street hopes that the Study Committee, City of Evansville Common Council, and City Administrator are encouraged by the study findings and are enthusiastic about moving forward with the capital campaign to support these exciting plans for developing new community resources.
- ➤ It is recommended that the Study Committee continue to be the Lead Agent to move the planning and organization of this project ahead, and to act as the preliminary core group for creating the fundraising initiative's Campaign Steering Committee.

Exhibit A Campaign Phases and Timetable

Phase I - Organization/Readiness and Advance Gifts 5 months: December 2021 through April 2022

Phase II - Leadership Gifts Phase 9 months: May 2022 through January 2023

Phase III - Community Gifts/Public Phase 3 months: November 2022 through January 2023

Note: the timing of the phases above takes solicitation constraints into consideration and we will need to be respectful of other fundraising program activities in Evansville and surrounding communities.

➤ Careful planning and campaign direction will be required to complete the project in a successful, professional manner. BSCG strongly suggests that an Awareness Building

- Initiative should be implemented, and that presentations to key prospective funders be completed early in Phase I. This activity will be necessary to position the City's vision and plans to receive the strongest, and most enthusiastic, showing of community support.
- ➤ Organizing the Campaign Steering Committee should be the highest priority in the beginning phase of the campaign. BSCG recommends that during Phase I, the current Study Committee continue to serve as the preliminary Campaign Steering Committee (6-10 people) to lead this initiative. The City Administrator (or other designee) should also serve as a member of the Campaign Steering Committee. By the beginning of Phase II, this core group should later be joined by additional volunteers to serve as the fully assembled Capital Campaign Committee. BSCG recommends that this expanded Campaign Committee consist of fifteen to twenty (15-20) people representing various segments of Evansville and nearby communities with a stake in the Parks Projects.
- ➤ Strengthen the Case for Support to tell the story of the Parks Projects in a more compelling way and include ideas gained from the study interviews, as well as address concerns that arose during study interviews. Additionally, the Case must clearly demonstrate the need for the upgrades and revitalization, as well as specifically illustrate how they will benefit the various segments of the community.
- ➤ BSCG found no other major fundraising initiatives or campaign projects underway or being planned in the near future in Evansville.
- ➤ BSCG respectfully suggests that strong consideration be given to retain fundraising counsel to serve in the role of Campaign Coach, with the primary task of providing guidance to the Capital Campaign Program. BSCG will also be available with organization development topics as well as those relating to marketing and philanthropy in general.
- Many interviewees asked to be kept informed as the project moves forward, which Baker Street consultants view as a positive sign of support.

II. Study Methodology

Fundraising is more an art than an exact science. Experience gained by those who have been engaged in Capital Campaign Programs indicates that there are key ingredients which have come to characterize successful endeavors.

The basic function of the Planning and Feasibility Study was to determine, as accurately as possible, how well-positioned the City of Evansville is to achieve the traditional standards and hallmarks associated with successful Capital Campaign Programs. In this report, Baker Street Consulting Group highlights those key topics designed to assist in determining fundraising feasibility and to assess the potential for launching the most fitting campaign for the purposes and magnitude currently under consideration by the City.

By speaking with people who may have input and influence vital to the potential outcome of the proposed project, a mosaic of the strengths and weaknesses for its ultimate success began to take shape. The picture is further clarified by the experience of the BSCG consultants who weigh these images, opinions, and ideas against the known ingredients of successful campaigns to determine the most appropriate course of action for this particular campaign.

To this purpose, Baker Street Consulting Group used the following methods to gather and analyze study-related information:

- Telephone / Zoom interviews.
- Informative discussions with the Study Committee and City Administrator.
- Baker Street's assessment of the City's internal readiness for a campaign.
- The City Administrator has spoken with BSCG consultants to provide information regarding the Parks Projects and internal readiness of the City to conduct a capital campaign.
- A review of the historic patterns of fundraising in Evansville.
- An environmental scan and assessment of recent and anticipated significant fundraising activities throughout the area that might impact a campaign for the City.

With BSCG's guidance, members of a Study Committee compiled a list of individuals to be invited to participate in the study. Invitations were mailed to these people by the City, and BSCG followed up to them through several means.

- Interviewees were mailed a formal Letter of Invitation to participate along with a preliminary Vision Statement and an insert with additional information.
- BSCG consultants followed up via email and telephone to schedule and complete personal interviews.
- In some cases, Study Committee members made personal outreach contacts to encourage participation.
- BSCG consultants made every effort to involve as many people in the one-on-one study interviews as possible.

The Baker Street Consulting Group consultants assigned to complete this study consisted of Mr. Jim Radford, President and Lead Consultant, Ms. Amy Radford, Senior Consultant, and Mr. Zach Radford, Senior Consultant. The City organized a Study Committee to assist in creating the list of study participants, preliminary Case for Support (Vision Statement) and other study materials.

Mr. Jason Sergeant, City Administrator, was our primary contact during the study. The Study Committee consisted of Sharon Cybart, Krista Korfmacher, Susan Kruser, Troy Larson, Jason Sergeant (ex officio), and Mark Schwartz.

Dear Mayor Hurtley:

Thank you for considering our proposal to conduct a Capital Campaign Program for the City of Evansville's revitalization and upgrade to the West Side Park and Leonard-Leota Park Project.

Now that the Feasibility Study has been completed, we look forward to a continued relationship with the City of Evansville by helping to plan and implement the Capital Campaign Program in a successful manner. To this purpose, I am submitting this Letter of Agreement to outline our proposal and to formalize our assignment.

Baker Street Consulting Group (BSCG) proposes to serve as Campaign Director and consultants for the capital campaign that will raise funds to meet the City of Evansville's pressing needs. Baker Street will provide staffing support and experienced counsel to assist the City of Evansville in a Capital Campaign Program to help achieve its fundraising goals for the park revitalization and upgrades project. Our firm's major gift experience, confident direction, and personal staffing assistance with assure a positive and productive campaign for the City of Evansville. The campaign will be conducted in a manner that will be a positive reflection upon the City of Evansville and follow all best practices for a fundraising endeavor of this kind.

The Scope of the Project, cost, and details associated with Baker Street Consulting Group serving as Campaign Director and consultants for the Capital Campaign Program are herein contained.

Appropriate refinements may occur after further discussion in order to implement the program in the most effective, tailored manner. However, no material change to this agreement will become effective unless in writing and signed by the Mayor or his designee.

Scope of Project

The scope of the project will encompass the following activities to be completed by Baker Street Consulting Group in cooperation with the City of Evansville and the Campaign Steering Committee:

- Implement BSCG's recommendations from the Feasibility Study Report.
- Direct the campaign and see to its most favorable outcome.
- Oversee and assist in the implementation of the Campaign Plan for conducting the campaign and make refinements from time to time to meet emerging circumstances and opportunities.
- Offer creative ideas and thoughtful strategies to position Evansville for the campaign, attract community leaders to serve in campaign roles, and secure the campaign's goals.
- Monitor all appropriate aspects of the Capital Campaign Program for the maximum benefit to the City of Evansville and successful advancement of the park revitalization project.
- Assist in providing input to identify and recruit campaign leadership and assist with organizing the campaign volunteer structure.
- Provide all necessary staff and volunteer training, including creating fundraising training materials.
- Assist with the process of creating a list of potential individual/family, corporate, and foundation Leadership/Major Gift Donors.
- Work with staff and volunteers to develop Approach Strategies for major donor prospects.
- Provide guidance and support to Solicitation Teams and assist with appropriate followup activity.
- Work with volunteers and staff to create proposals for lead gift and major gift presentations. Assist in meeting with prospective donors as needed.
- Organize Solicitation Teams to secure gift/pledge commitments.
- Assist in creating and refining the Naming Opportunities for the project as may be necessary.
- Assist with creation and overall implementation of an appropriate Donor Recognition Program.
- Coordinate the development of any campaign materials, e.g., Case for Support, brochures, letterhead, PowerPoint Presentations, Talking Points, etc.
- Assist with drafting and submitting proposals to select foundations.
- Create presentation materials and write letters/proposals in support of fundraising calls and presentations as needed.
- Assist the staff and Campaign Committee in conducting the campaign to ensure best practices by national standards.

- Assist in planning and preparing materials and agendas relating to campaign meetings.
- Attend committee and planning meetings as necessary.
- Attend campaign functions as necessary.
- Assist in making select presentations and securing gifts necessary to reach the campaign dollar goal.
- Provide timely activity/progress reports the City Administrator and Campaign Steering Committee.

Project Time Frame

This agreement will encompass all the aforementioned services provided by Baker Street Consulting Group for a fourteen-month (14) period of time. The City of Evansville's approval to proceed with the campaign will serve as the beginning date. A detailed Campaign Plan and Guide will be prepared once the City of Evansville's leaders decide to move forward with the campaign and this agreement.

The Campaign Plan and Guide will contain, among other details, an articulated budget, activities schedule, strategies, assignments of tasks, fundraising milestones, and deliverable products associated with campaign administration.

Service Fees and Expenses

Baker Street Consulting Group will perform the activities described above, and any other consulting services as necessary, in order to effectively direct this campaign to a successful conclusion. Ideally, our services will begin in December 2021 and continue through January 2022. The total cost for professional services will be \$140,000.

Our project-related expenses (e.g., travel) are estimated to total \$7,000 for the project duration (average ~\$500/ month), and will be billed monthly at cost, along with our professional services fee invoice to the City of Evansville. Standard Terms and Conditions

The following terms are incorporated into any Agreement between Baker Street Consulting Group (the "Firm") and the City of Evansville (Evansville) as (the "Client") identified in the Agreement.

- 1. **Execution and Delivery.** If the Agreement is executed by the Client and returned to the Firm more than thirty-days (30) after its execution by the Firm, the Firm reserves the right to reconsider the Agreement.
- 2. Time-based Fees. The fees specified in the Agreement are based on the time projected to complete the specified contracted services. It is anticipated that the projected time will be adequate. If additional time should be required to complete the services, the Firm reserves the right to propose revising the attached Agreement, provided, however, that no such revision shall become effective without the prior approval of the Client. Any changes requested by the Client from the services specified in the Agreement shall be subject to additional fees to be negotiated between the Client and the Firm.
- 3. **Personnel Assigned.** While it is anticipated that there will be no change in the Firm members involved, the Firm reserves the right to change the consultant(s) servicing the Client under the Agreement. The Client reserves the right to request a change in consulting personnel assigned to the project by the Firm.
- 4. **Non-employment.** Neither the Client nor the Firm will recruit, hire, contract or consult for a fee with any member of the other organization during the term of this Agreement nor for six (6) months following its termination, without the prior written agreement of the other party.
- 5. **Expenses/Support Services.** Unless specifically provided otherwise in the Agreement, the Client will reimburse the Firm for all reasonable expenses (such as travel, meals and lodging) actually incurred by the Firm's staff members in connection with providing services under the Agreement and for all reasonable, and pre-approved, costs incurred by the Firm for support services, such as word processing, copying and graphic design.

- 11. **Firm as Independent Contractor.** The Firm is rendering services under the Agreement as an independent contractor and not as an agent or employee of the Client.
- 12. Force Majeure. The Firm's performance under the Agreement will be excused without liability when prevented by strike, act of God, governmental action, accident or any other condition beyond its reasonable control.

Overall Highlights:

- -Both license will expire on December 31st
- -Added Police Chief & City Clerk to the definitions to read "Police Chief or Chief of Police means the City Police Chief and/or designated representative City Clerk or Clerk means the City Clerk and/or designated representative." So that others such as the Lieutenant or Deputy Clerk are able to take care of these in case of someone's absence.

Mobile Vendor

- -Mobile Business no longer require a peddler's permit but there will still need to be a background check ran.
- -Added that we need a copy of WI Sellers Permit
- -These were previously issued by the Zoning Administrator but will now be handled primarily by the Clerks' office but will be reviewed by the Police Chief & Zoning Administrator.

Peddler's License

- -Change the name from Peddler's, Canvasser, Transient Merchant's or Transient Photographer's License to "Solicitor" so it's all encompassing
- -Increase the Solicitor's license fee from \$75 to \$100. This is to cover the cost of review by the Clerk's office, Police Dept., background check and license printing fees. The last increase for this license was in 2009.
- -Solicitor's License now require 2- 2x2 photos to be included with the application; one to be attached to the license and one to be kept in the file. (Sec 90-4(10))
- -Outline what may constitute as a non-recommend (Sec 90-5(c)(2))
- -Restrict times that they can't solicit- no soliciting between 8pm-9am (Sec 90-9(a)(3))
- -Made sure to note that a license is not needed for city, county or state employees on official business or candidates for local political elections (Sec 90-3(1))
- -For Reprints there will be a \$5 fee and they must submit 2 additional 2x2 photos.
- -Added a revocation section which includes making any fraudulent, false, deceptive or misleading statement or representation in the course of engaging in direct sales.

- (e) The Mayor or City Council may suspend the license of a licensee under this article without hearing for not to exceed ten days.
- (f) The Police Department shall repossess any license revoked under this section.

- (b) Weights and Measures Program. The program that includes administration and enforcement of this section, Chapter 98, Wis. Stats., and applicable Wis. Adm. Code provisions, and any related actions.

Sec. 22-54. Weights and Measures Participation Required.

- (a) Except as provided in subsection b, each and every person, corporation, limited liability corporation, limited liability partnership, business group, organization or other entity who holds, owns, possesses, operates and/or maintains any commercial weighing or measuring devices or any other weights and measures or systems and accessories related thereto which are used commercially within the City of Evansville for determining the weight, measure or count is deemed to be a participant in the City of Evansville Weights and Measures Program subject to the provisions of this article.
- (b) Exemptions. Sales permitted at any farmers' market or other similar event in the City which has been otherwise lawfully permitted, licensed or approved as required by the City Code or sales permitted by direct seller, transient merchants and solicitors are exempt from licensing under this section.

Sec. 22-55. Fees Assessment.

- (a) Annual Assessment. The City Clerk shall annually assess fees and mail invoices to each participant in the City of Evansville Weights and Measures Program by May 15th and due by June 30th. Assessment fees will be based on the number and types of weighing and measuring devices as indicated by the Department of Agriculture, Trade and Consumer Protection. The total of the fees assessed and the fees collected shall not exceed the actual costs of the City of Evansville Weights and Measures Program.
- (b) Failure to Pay Assessment. If the assessment fee is not paid by June 30th of each year, an additional administrative collection charge of ten percent (10%) of the fee shall be added to the amount due. A participant failing to pay the assessment shall not be issued any alcohol beverage license or cigarette license until such fee is paid in full. If the participant is the owner of the real estate premises where the weighing and measuring device is located, any delinquent assessment shall be extended upon the current or the next tax roll as a charge against the real estate premises as provided in Section 66.60(16), Wis. Stats.
- (c) Change of Ownership. If the ownership of the participant is transferred during the year, the owner of the participant as of June 30th of the current year shall be liable and responsible for the payment of the fees assessed under this article.

Article IV. Mobile Businesses

Sec. 22-61. Purpose of Article.

The purpose of this article is to provide regulation of Mobile Businesses, defined in this chapter, to promote the health, safety, comfort, convenience, prosperity, and general welfare of the citizens by requiring that new and existing mobile food vendors provide residents and customers with a level of cleanliness, quality and safety. It is also the intent of these regulations to establish reasonable guidelines and restrictions for mobile food carts to operate within city limits by averting imbalanced favor against brick and mortar businesses, while allowing for a diversity of businesses.

Sec. 22-62 License Required.

No individual, partnership, corporation or other for-profit entity shall operate a mobile business without first having obtained a Mobile Business License as provided for in this article. Mobile Businesses operating in association with community sponsored events are exempt from the applicable fees but must have the city's consent and provide copy of liability insurancethis article.

Sec. 22-63. Definitions.

The following words, terms and phrases, when used in this article shall have the meanings given to them within this section.

Goods means personal property of any kind including but not limited to food products which are prepared or prepackaged.

<u>Mobile Business</u> means a for-profit business which has no permanent address in the city and which is selling goods from a motor vehicle, trailer, or food cart.

<u>Nonprofit Organization</u> means a corporation, trust or community chest, fund or foundation or other entity organized and operated exclusively for religious, charitable, scientific, literary or educational purposes, no part of the net earnings of which inure to the benefit of any private shareholder or individual.

Police Chief or Chief of Police means the City Police Chief and/or designated representative

City Clerk or Clerk means the City Clerk and/or designated representative.

- (b) (2) Signage Plan-Each application for a Mobile Business License shall include a signage plan for the subject property showing, at a minimum, proposed signage as well as proposed signage illumination. The signage plan must be in accordance with Article X. Sign Regulation.
- (e) (3) Recommendation-The Zoning Administrator shall review applications for Mobile Business Licenses for compliance with the requirements of this chapter. The Zoning Administrator shall have authority to require modifications to the proposed site plan in the interest of public safety. After review of such application, the Zoning Administrator shall forward the site plan to the Clerk, with a written report stating whether the site plan is in compliance with the requirements of this article.

Sec. 22-65. Investigation

- (a) Background Check-Upon receipt of an application and fee, the City Clerk shall referthe application to the Chief of Police. The Police Chief shall make an investigation of the accuracy of the statements made in the application and determine whether the applicant has been convicted of a felony, misdemeanor, statutory violation punishable by forfeiture, or county or municipal ordinance violation in which the circumstances of the felony, misdemeanor, or other offense substantially relate to the circumstances of the permitted activity and, if so, the nature and date of the offense and the penalty assessed.
- (b) Non Recommend-If, as a result of an investigation, the Police Chief discovers that any representation on the application contains a material omission or inaccuracy, or the Police Chief is of the opinion that the applicant is not a fit person to conduct such sales, the Police Chief shall return the application to the City Clerk for referral to the Public Safety Committee who shall approve or disapprove the application to the City Clerk. Upon return of a disapproved application, the City Clerk shall notify the applicant that the permit has been denied, along with the reasons therefore.
- (c) **Recommendation**-If as a result of an investigation, the Police Chief is of the opinion that the applicant is a fit person to conduct such sales, the Police Chief shall endorse on the application his/her approval and return the application to the City Clerk to be reviewed by the zoning administrator.

Sec. 22-66. License Issuance.

- (a) Following receipt of the peddlers license and approval of the Mobile Business License application, the Zoning Administrator or City Clerk may grant the Mobile Business License
- (b) The Zoning Administrator or City Clerk may refuse to approve the application if it is determined, pursuant to the requirements described in this article that the application contains any material omission, inaccuracies, or that the applicant was convicted of a crime, the nature of which is directly related to the applicant's fitness to engage in the operation of the mobile business.

- (3) The mobile business may be permitted on private property with a letter from the property owner verifying permission, or on school district property with a letter from the school district verifying permission.
- (4) Not less than two parking stalls per customer and employee shall be required for every eight feet of the mobile business.
- (5) Hours of operation are limited to the hours of 7:00 a.m. to 10:00 p.m. Sunday through Saturday.
- (6) No sales of alcoholic beverages are permitted.
- (7) The mobile business may not generate noise louder than levels produced by the equipment used in operating the mobile business.
- (8) Each mobile business shall be capable of being moved and kept under control by one person. All traffic laws shall be adhered to during operation of the vehicle.
- (9) Each mobile business shall be moved safely to and from its vending location.
- (10) Each mobile business shall be secured at all times so as not to injure or endanger persons or property.
- (11) Each mobile business shall be equipped with at least one leak-proof container for the deposit of waste, garbage, litter, and refuse. A second leak-proof container for the deposit of recycle materials is also required. All such containers shall be kept covered with tightfitting lids. When leaving the sales area, the licensee and his or her employee shall be responsible for the removal of all litter resulting from his or her business or customer's use of his or her business.
- (12) Each operator, licensee and mobile food vending vehicle shall comply with all state and county laws, codes, regulations, and standards relating to serving and selling food and food products.
- (7)(13) An operator shall be personally and physically present inside or next to the mobile food vending vehicle at all times during which items are displayed or sold.

Any person, firm or corporation violating any provisions of this article may, upon conviction, have their license revoked and shall further be punished by a forfeiture of not less than \$50.00 or more than \$1,000.00. Each day's violation constitutes a separate offense.

Sec. 90-1 Registration Required

It shall be unlawful for any solicitor to engage in direct sales or solicitation activities within the City of Evansville without first obtaining a license therefor in compliance with the provisions of this division.

Sec. 90-12. Definitions².

The following words, terms and phrases, when used in this chapter, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

- (a) "Business" includes all vocations, occupations, services, professions, enterprises, establishments and all other kinds of activities and matters intended to generate revenue or conduct for private profit or benefit, either directly or indirectly, located within the City's jurisdiction.
- (b) "Solicitor" is defined as follows:
 - (1) Any person, both principals and agents, as well as employers and employees, who intend to sell, offer for or expose for sale, or who shall trade, deal or traffic in, any property or services in the city by going from house to house or from place to place or by indiscriminately approaching individual, whether on foot or by vehicle.
 - (2) Person seeking to obtain orders, prospective customers or subscriptions for the purchase of goods, publication or services of any kind, character whatsoever, for any consideration whatsoever,
 - (3) Any person, while offering for sale any goods, wares, merchandise, services or anything of value, stands in a doorway or uses any building, structure, vehicle, unenclosed vacant lot, parcel of land or any other place not used by such person as a permanent place of business; or
 - (4) Persons seeking to obtain gifts or contributions of money, clothing or any other valuable thing for the support or benefit of any association, organization, corporation or project, not otherwise exempt under this chapter.
- (c) "Registered Solicitor" means and includes a person or business that has obtained a solicitor's permit as provided in this chapter.
- (d) "Residence" means and includes every separate living unit occupied for residential purposes by one or more persons, contained within any type of building or structure.

Canvasser __and sSolicitor__ mean aOne person who goes from place to place within the city soliciting orders for the future delivery of property goods or services to be performed in the future. It includes any person who occupies any place within the city for the purpose of exhibiting samples and taking orders for future delivery.

— Peddler. One who offers merchandise (such as fresh produce) for sale along the street or from door to door. One who deals in or promotes something intangible (such as a personal asset or an idea) means a person who goes from place to place within the city offering for sale property which he carries with him. It includes vendors who distribute their products to regular customers on established routes.

— Transient merchant . One_ means a person who engages at a fixed location in the city in the temporary business of selling property at such location. It does not include a person who does not sell from stock but exhibits samples for the purpose of securing orders for future delivery only. It includes a person who associates temporarily with any local business or conducts business in the name of a local merchant, dealer or auctioneer.

Transient photographer. One means a person who engages in the business of photography in the city temporarily and who does not intend to become and does not become a permanent photographer in the city. Included is anyone who engages in the sale or giving away of photographs, enlargements or coupons therefor from house to house, from an office, room, hotel, store, or home, or in conjunction with any local bona fide resident or business in the city.

<u>"Police Chief or Chief of Police"</u>. Shall mean the City Police Chief and/or a designated representative.

"City Clerk or Clerk". Shall mean the City Clerk and/or a designated representative.

Sec. 90-23. Exemptions from license requirement.

No license shall be required under this chapter of the following:

- (1) Officers or employees of the City, County, State or Federal Government, or any subdivision thereof, when on official business.
- (2) Persons selling personal property at wholesale to dealers in such articles.
- (2) Newsboys.
- (3) Merchants or their employees delivering goods in the to regular course of business customers on established routes; items to include but not limited to newspapers, fuel, dairy products-

- (4) Farmers or truck gardeners offering to sell the products of the farm or garden occupied and cultivated by them.
- (5) A veteran holding a special state license under Wis. Stats. § 440.51, but he shall comply with sections 90-69 and 90-7.
- (6) Any person soliciting for charitable, religious, patriotic or philanthropic purposes where the proceeds thereof are devoted solely to the purposes of the organization.
- (7) Sales required by statute or order of a court.
- (8) Bona fide auction sales conducted pursuant to law.
- (9) Minors under the age of eighteen (18) who are residents of the City of Evansville conducting "fundraisers" for youth programs, such as athletics, scouting or school programs.
- (10) Candidates for local political office, campaign workers, members and representatives of political organizations campaigning on behalf of local elections for petitions to be submitted to the City of Evansville.

Sec. 90-34. License application requirements fee.

- (a) Application information- The application for a Solicitor's Permit shall include the following information: Applicants under this article must complete and return to the City Clerk's office an application form furnished by the Clerk's office which shall require the following information:
 - (1) Name, permanent address and telephone number, and temporary address, if any.
 - (2) Height, weight, color of hair and eyes, and the date of birth.
 - (3) Name, address and telephone number of the person that the peddler represents or is employed by, or whose merchandise is being sold.
 - (4) Temporary address and telephone number from which business will be conducted, if any.
 - (5) Nature of business to be conducted and a brief description of the merchandise offered and any services offered.
 - (6) Proposed method of delivery of merchandise, if applicable.
 - (7) Make, model and license number of any vehicle to be used by applicant in the conduct of his business.
 - (8) Last cities, villages, towns, not to exceed three, where applicant conducted similar business just prior to making this registration.

- (9) Statement as to whether applicant has been convicted of any crime or ordinance violation related to applicant's transient merchant business within the last five years, the nature of the offense and the place of conviction.
- (10) Attached to the application form shall be two recent photographs of the applicant, which pictures shall be not less than two inches by two inches and showing the face and shoulders of the applicant in a clear and distinguishing manner
- (11) Any other information the deemed necessary
- (b) Identification and Certification-Applicants shall present to the City Clerk for examination
 - (1) A driver's license or other proof of identity as may be reasonably required.
 - (2) A state certified certificate of examination and approval from the sealer of weights and measures where applicant's business requires use of weighing and measuring devices approved by state authorities.
 - (3) Any application for a solicitor to engage in the sale of food or beverages shall be referred to the Rock County Health Department for approval and issuance on a certificate of health inspection. The applicant's equipment shall be subject to inspections by the Rock County Health Department at the time of application and at periodic intervals thereafter.

(c) Application fees

- (1) At the time of filing his application, the applicant for a license under this chapter shall pay to the City Clerk-treasurer a fee as established by the Council from time to time by resolution and as set forth in appendix A to cover the cost of investigation of the facts stated in the application.
- (2) Solicitors of funds or donations for charitable or other organizations shall comply with all provisions in this chapter, but shall be exempt from the application fee; such applicants, however, shall pay an amount equal to the CIB investigation fee currently charged by the Department of Justice.
- (3) Upon payment of the fee and pending completion of the investigation in sec. 90-5, the City Clerk shall register the applicant as a solicitor and issue the license. The license shall be valid for a period no more than one (1) year expiring on December 31st, subject to subsequent refusal as provided in Sec 90-5 below.
- (4) All fees paid under this chapter are non-refundable.

(d) License Reprint

- (1) If a license is reprint is need the application shall pay to the City Clerk a fee as established by the Council from time to time by resolution as set forth in appendix A.
- (2) If a reprint is requested two additional recent photographs of the applicant, which pictures shall be not less than two inches by two inches and showing the

Sec. 90-45. Investigation, Issuance and Denial and approval of license application.

(a) Background Check

- (1) Upon receipt of a completed application form and fee, the City Clerk shall indicate upon the face of the form whether the fee has been paid and then refer it to the Police Chief who may make and complete an investigation of the statements made upon the application form, the applicant or both.
- (2) The Police Chief shall review the application and either recommend or not recommend issuance of a licenses then return it to the City Clerk.

(b) Recommended

(1) In the event that the Police Chief recommends such application, the City Clerk shall issue a Solicitor's License to the applicant.

(c) Non Recommend

- (1) In the event the Police Chief does not recommend issuance of such application, the City Clerk shall not issue a solicitor license to the applicant.
- (2) A Solicitor's license may be denied if the Police Chief or the City Clerk find anyone or a combination of the following:
 - a. The application contains any material omission or any inaccurate, false, or misleading statement.
 - b. The applicant violated any provisions of any similar or related state, federal, or local ordinance or law anywhere in the previous five years.
 - c. That there is a reason to believe that the applicant or the company violated any provision of any similar or related state, federal or local ordinance or law anywhere in the previous five years.
 - d. The applicant failed and/or fails to comply with any provisions in this chapter.
 - e. Within the previous 10 years, committed any act consisting of fraud or misrepresentation directly related to the occupation of solicitor.
 - f. Within the previous 10 years, been convicted of a misdemeanor or felony involving moral turpitude or assault.
 - g. Committed any offense for which registration as a sex offender is a legal requirement of conviction for that offense.
 - h. The Chief of Police finds that the applicant's proposed activity and/or issuance to the applicant of a Solicitor's license might not be consistent with, or might be contrary to, or might not be in the best interest of, or otherwise not in the furtherance of, the health, safety or welfare of the community.

Every applicant for a license under this chapter who is not a resident of the county or who represents a firm whose principal place of business is located outside of the state shall file with the city clerk-treasurer a surety bond in the amount of \$500.00, approved by the clerk-treasurer, conditioned that the applicant will comply with all provisions of the ordinances of the city and state laws regulating peddlers, canvassers, solicitors, transient merchants and transient photographers_solicitors, and guaranteeing to any person doing business with the licensee that all money paid as a down payment will be accounted for and applied according to the representations of the licensee, and further guaranteeing that property purchased for future delivery will be delivered according to the representations of the licensee. Action on such bond may be brought by any person aggrieved.

- (8) In the event that the person is acting on behalf of a charitable, benevolent, educational or non-profit organization or corporation, refuse to specifically and accurately disclose, as a percentage of the sale or donation price of the goods or services, the portion of the sale or donation price of the goods or services offered which shall actually be used for the charitable, benevolent, educational or nonprofit purpose for which the solicitation is being made.
- (9) Violate any other ordinance or law.

(1) After the initial greeting and before any other statement is made to a prospective customer, a peddler shall expressly disclose his/her name, the name of the

- company or organization he/she is affiliated with, if any, and the identity of goods or services he/she offers to sell.
- (2) If any sale of goods is made by a peddler, or any sales order for the later delivery of goods is taken by the seller, the buyer shall have the right to cancel the transaction if it involves the extension of credit of more than twenty-five dollars, or is a cash transaction, in accordance with the procedure as set forth in Section 423.203 of the Wisconsin Statutes; the seller shall give the buyer two copies of a typed or printed notice of that fact. Such notice shall conform to the requirements of Sections 423.203(1)(a)(b)and (c), (2) and (3) of the Wisconsin Statutes.
- (3) If the solicitor takes a sales order for the later delivery of goods, he/she shall, at the time the order is taken, provide the buyer with a written statement containing the terms of the agreement, the amount paid in advance, whether full, partial or no advance payment is made, the name, address and telephone number of the seller, the delivery or performance date and whether a guarantee or warranty is provided, and, if so, the terms thereof.
- (4) Possession/Display of License. Solicitor shall at all times when engaging in direct sales activities, have on their person and visibly display to the public, the license issued pursuant to this section, as well as photo identification. Solicitors shall show their license to sell issued by the City of Evansville, as well as photo identification upon request.
