**Maple Hill Cemetery
Information**

Fees for columbarium niches, lot purchases, interments, and information on Maple Hill Cemetery are available at the City Clerk’s Office. All lots hereafter sold in the City cemetery shall be provided with perpetual care services, the expense to be included in the price of the lot.

Decorations

- No more than two decorations on any marker or monument are permitted.
- All decorations must be in a pot, vase, or placed on an approved upright support and placed within six inches of the memorial. All winter decorations must be on an approved upright support.
- All summer decorations must be removed by November 11 and no winter decorations may be installed until the Monday before Thanksgiving.
- All decorations must be removed by April 15.
- No decorations, other than fresh cut flowers may be placed on any grave until four days prior to Memorial Day. Any decorations placed prior to this date may be removed without notice.

Advanced Disposal is our refuse and recycling provider. The City of Evansville is on the cart system with Advanced Disposal. Cart sizes are 35, 64, or 96 gallon. You will receive one cart for refuse and one cart for recycling. They have to be the same size. If do not have carts for your property, please call City Hall at 882-2266. WINTER
PARKING
November 30
– April 1



From November 30 to April 1 each year, winter parking regulations are strictly enforced between the hours of 1:00 a.m. and 7:00 a.m. Between these hours, your vehicle should be parked on the side of the street consistent with the date. For example, from 1:00 a.m. – 7 a.m. on odd days, your vehicle should be parked on the odd side of the street; on even days, it should be parked on the even side. If you park your car at the end of the day before midnight, remember to anticipate the date change that will occur at midnight. Please call the Police Department at 882-2292 with questions.

Salvage Vehicle Inspections Available – hours vary and inspections are done by appointment only. Information packets are available in the Police Department lobby.

Motor Vehicle & DNR Registration and Licensing

Vehicle title, registration and/or registration renewal services for walk-in customers. Plates or stickers are given to the customer upon completion of the transaction. Titles are printed and mailed from the WI Dept. of Transp. In addition, registration for boats, ATV's, & snowmobiles, as well as, licensing for hunting, fishing & trapping. There is a small fee for these services which are available Monday – Saturday from 7:00 a.m. – 7:00 p.m.

Prescription Drug Drop-Off

A permanent drop-off box to provide citizens of Rock County with an easy, secure and responsible way to dispose of unused, unwanted and expired prescription drugs is available 24/7 at the entrance to the police department.



2016 ANIMAL LICENSES

According to State Statute and City of Evansville Ordinance 2015-01, all dogs, cats and exotic animals must be licensed annually. 2016 licenses are available after December 15, 2015. Licenses can be applied for at the City Clerk's Office. A current rabies certificate and proof of distemper vaccination from your Veterinarian is required when applying for the license. Fees are as follows:

- Unaltered Animals \$15.00
- Spayed or Neutered \$ 8.00
- Exotic Animals \$ 8.00
- Licensed Boarder Fee \$75.00

Late fee applied after March 31st

According to City Ordinance, a fine may be imposed by our Police Department if an unlicensed animal is picked up and held at our local pound.

Evansville's city library is the Eager Free Public Library, located at 39 W Main St. It is open Monday – Thursday, 9:30 a.m. to 7:00 p.m., Friday, 9:30 a.m. to 6:00 p.m., and Saturday, 9:30 a.m. to 1:00 p.m. Library cards to check out books, DVDs, audiobooks, e-books, and CDs, are free to any area resident.

Library programs and services include computers for public use, a book discussion group, author visits, speaking engagements, computer instruction, copier and fax service, delivery to homebound individuals, and a meeting room for public use. Many programs are offered for children and teens, including story times for toddlers and preschoolers, early release day activities, and technology workshops. **LEAF
PICK UP**



Fall leaf pick-up occurs from the middle of October until Thanksgiving. For this collection period, only leaves should be raked into the street at the curb line. Because of possible danger to employees, the public, and equipment, only leaves can be raked into the street.

BRUSH/YARD WASTE

Brush/Yard waste pick up is done from April through October, and occurs during the first full non-holiday week of each month. Yard waste must be bagged and brush must be stacked in bundles no longer than 6' and placed at the curb. No yard waste or brush shall be placed in the street. The Public Works employees will make only one pass through the City each month. There will be no additional pick-ups throughout the month so please mark these dates on your calendar.

BRUSH/YARD WASTE SITE

For your convenience the City also has a brush/yard waste drop off site on Water Street for residents. Weather permitting the site is open on Saturdays from 9 a.m. to 2:30 p.m. from mid-April until the Saturday before Thanksgiving. It is also open on Wednesday evenings from 5:00 p.m. to dusk during daylight savings time (the nearest landfill is located in the City of Janesville). Please watch for further notices in our local newspaper for waste site hour changes in the spring. You may call the Clerk's Office for further information, (882-2266).

FLOODPLAIN INFORMATION

Information on whether your property is in the 100-year floodplain can be obtained at City Hall. The Building Inspector, Community Develop. Dir, City Clerk, or City Administrator can help you. Maps are available to look at as well as other flood-related information. The City also maintains elevation certificates for construction in 2009 and newer; call the Building Inspector at 608-259-6860.

If you are building in the floodplain, purchase of flood insurance is mandatory if using a federally regulated/insured bank for a loan. Find more information at:





2016 BUDGET: General Fund expenditures will total \$3,146,217, an increase of \$54,694 or 1.77% from 2015.


GENERAL FUND BUDGETED EXPENSES

TAX BILLS & LOTTERY CREDIT

City of Evansville taxes are collected by the Rock County Treasurer's Office between the hours of 8 a.m. - 5 p.m., Monday - Friday. Their offices, as well as City offices, will be closed for the following holidays: Thursday, Dec. 24th, Friday Dec. 25th, and Friday, Jan. 1st.

Full or first installment payments are due on or before January 31, 2016. Checks **must** be made payable to the **Rock County Treasurer** and mailed to: PO Box 1508, Janesville, WI 53547-1508. Include the top portion of your tax bill with your payment. Please reference your parcel number on any correspondence. Payment can be made by check, money order, or pay by Credit Card or Electronic Check using GovTech Services on the Rock County website. Go to <http://www.co.rock.wi.us/> and click on Treasurer to begin the process. **If you are requesting a receipt, please enclose a self-addressed, stamped envelope.**

You may claim the lottery and gaming credit for 2015 taxes, payable in 2016 if, on January 1, 2015, you were the owner of the property and used that property as your primary residence. If you are eligible for a lottery credit and it does not appear on your tax statement, please contact the Evansville Clerk's Office for an application.
