We are working with our colleagues in Rock County on MOU's for HART and DEC. We are also working on a plan for cyber-attacks (CRRP). Roger Berg has started the bathroom maintenance project. Youth2Youth 4 Change inspected 7 establishments June 28<sup>th</sup> and had 2 tobacco sales. One at Evansville Cenex and one at Casey's General Store. Youth2Youth 4 Change will be following up with each establishment with a letter notifying them and providing training options for their staff. EPD was involved and issued citations. Calls for June were 1156 in 2018; and 900 in 2017. Number of license plate transactions for June 2018 were 46.
