Resolution 2017-26

Amending Sanitary Sewer Fixed and Variable Rates 2018 - 2022

WHEREAS, Municipal Code 126-401 states “The fixed charge amount shall be determined from time to time by resolution by the City”; and

WHEREAS, Municipal Code 126-402 states “The variable charge amount shall be determined from time to time by resolution by the City”; and

WHEREAS, the recent improvement costs for the Waste Water Treatment Facility calls for an increase in revenue to maintain debt payments and operations; and

WHEREAS, the City shall incrementally increase sewer revenues to establish sufficient funds to maintain current and future capital improvements.

WHEREAS, the City shall increase the average sewer charge an approximate 20% in 2018, 20% in 2019 and 5% in each following year 2020 -2022.

WHEREAS, the City shall closely follow a ratio setting for all fixed sewer charges as follows:

- 5/8 – 3/4 inch meters = 1
- 1 inch meters = 2.5
- 1 1/4 inch meters = 3.5
- 1 1/2 inch meters = 5
- 2 inch meters = 8
- 3 inch meters = 15
- 4 inch meters = 25
- 6 inch meters = 50

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Evansville the sewer rates shall be set starting the 1st billing cycle of each of the following calendar years:
